Program wise Requirement of Teaching Posts for the Academic Year 2021-2022

The Vice-Chancellor explained to members of the Board of Governors that REVA University will be offering 71 programs during the academic year 2021-2022. To meet the teaching requirement there are 934 teachers required for the academic year 2021-2022. This requirement of teaching posts has been calculated based on the intake of students for the proposed new programs and the number of students of earlier years on roll. The program wise details of teaching faculty required for the academic year 2021-2022 is provided in the annexure below. The subject is placed before the august house with a request to consider and grant sanction for 934 teaching posts for the academic year 2021-2022 as detailed in the table given below.

Decision:

The members of the Board of Governors deliberated in detail about the program wise requirement of teaching posts and unanimously decided to sanction 934 teaching posts for the academic year 2021-2022 as detailed below.

The Chairman informed to the Board about the resignation of the Vice Chancellor Dr.Mallikarjuna Babu due to personal reasons. It was informed to the Board on the need for constitution of Search Committee for which the BoG should nominate two members as per the REVA University Act. After deliberations the Board anonymously authorized the Chancellor and Chairperson of the BoG top nominate two persons on behalf of the BoG.

CHANGE IN THE NAME OF IT DEPARTMENT TO ICT – INFORMATION AND COMMUNICATION TECHNOLOGY


It was informed to the Board that department of IT and ERP are working on multiple technologies to automate the functions, application and create user experience by providing user friendly Infrastructure solutions. Both departments are focused towards integration of various technologies, better communication and user support.

Hence the proposal was made to merge both departments and create one department as ICT – Information and Communication Technology department. After evaluating multiple universities and other technology organizations it was proposed to create one department and rename it as ICT department instead of Department of IT and ERP. It was told that department will be responsible to take care of all the technology enablement, Integration and support for the University.

The Board after due deliberations resolved to approve the decision taken.
