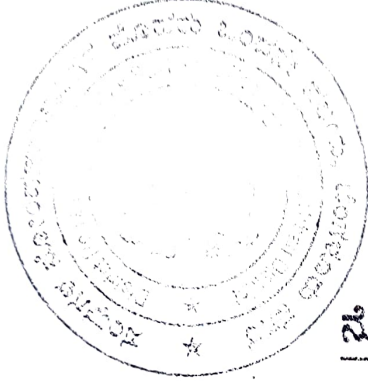

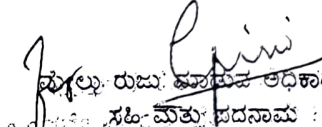
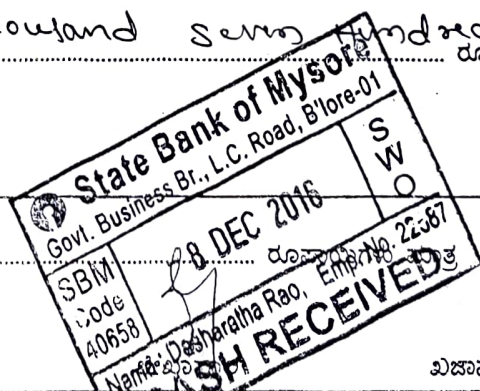

If the Association Governing Committee decides to have its office at any other address, then it is free to do so, but will always be in the town of Bengaluru, Karnataka.

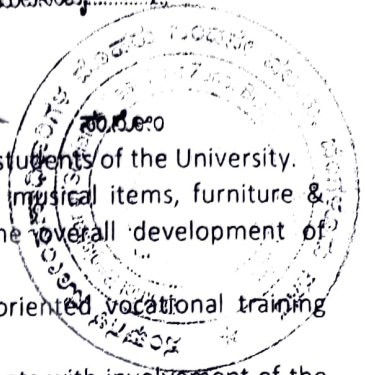
C. AREA OF OPERATION

To provide external support for the upliftment of the University & to care for the well being of students, teachers & other staff of the Reva University

D. OBJECTS

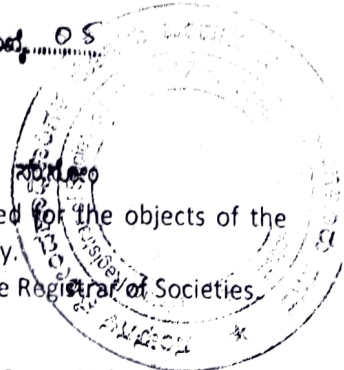
- i. To provide external & unstinted support in all academic, co-curricular & extra-curricular activities of the University.
- ii. To become brand ambassadors of the University
- iii. To donate funds on voluntary basis for the health & welfare of the students, teachers & other staff of the University.
- iv. To donate funds on voluntary basis for the support of needy students as identified by the University.
- v. To provide endowments (i.e. lump-sum funds), so as to make scholarships in monetary form from its earnings, available to the needy students of the University.

- vi. To sponsor co-curricular & extra-curricular activities for the students of the University.
- vii. To donate funds to obtain reading material, sports items, musical items, furniture & fixtures and other paraphernalia that is required for the overall development of students of the University.

- xx. To create & maintain the website of the University along with that of Revva University Alumni Association.
- xxi. To contribute & take part in the health, welfare & social activities of the students, teachers & other staff of the University.
- xxii. To raise funds by subscription from ex-students and former students of the University.
- xxiii. To encourage and provide assistance to the University to get certain Board affiliations such as CBSE, ICSE, IGCSE, etc. after obtaining permission from the University management.
- xxiv. To accept any request, gift, donation, endowment or subscription or to accumulate and provide any fund or endowment to invest the same and apply the income arising there from or to resort to incurring of capital expenditure thereof for attainment of the objects of RUAA.
- xxv. To manage & deal with the funds & monies of this Revva University Alumni Association.
- xxvi. To have its own office, staff & create necessary infrastructure for managing the affairs of Revva University Alumni Association in an efficient & very transparent manner.
- xxvii. To make Rules & Bye-laws for the conduct of the affairs of the Revva University Alumni Association and alter, amend, vary or rescind them from time to time.

Rules & Regulations

1. Membership of RUAA

- a. Only the ex-students who have completed one full academic year at the Reva University shall be considered as Member of RUAA. RUAA membership is for life, once enrolled.
- b. All the members shall pay a minimum one time nominal registration fees of Rs. 500 (Rupees five hundred only) to be considered as part of RUAA. The RUAA Governing Committee may revise the registration amount from time to time after deliberations during its meeting called specifically for the purpose.
- c. There will be no annual membership fees to be paid by any members of RUAA. However the members may voluntarily donate to the RUAA in cash or kind or as may be requested by the Alumni Association.
- d. All members of the Society are eligible to vote and Contest to managing committee in the General Body Meeting.
- e. If the subscription of the member is in arrears for more than three months without satisfactory explanation to the Secretary , his/her name will be removed and the Executive Committee may reconsider his/her application for re-admission of membership.
- f. The termination of membership on death, the member acting against the objects of the Association unsound mind and other reasons stated by executive committee.
- g. All members may take part in the proceedings of the General meeting. Only such members who have completed minimum period of 6 months as members shall exercise their vote.

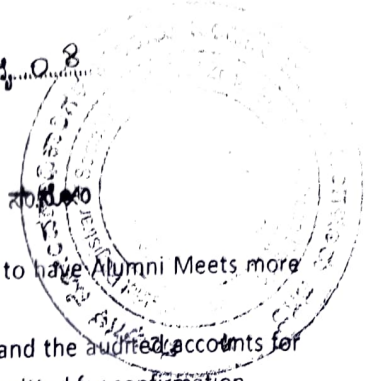
2. Information required by the members:

Any member of the Association may apply to the Secretary for any information as may be required or any matter of the subjects or Rules and regulations of the Association.

3. General body and other meetings:

- a. The RUAA Governing Committee members shall conduct one Alumni meet every year with a specific theme or focus which would serve as a get-together of all Alumnis along with

spouses & children, if any. If expedient, the RGC could decide to have Alumni Meets more often.

- b. The report of the Management of the previous years working and the audited accounts for the one period and proceedings year shall be discussed and submitted for confirmation.
- c. An Executive committee consisting of 09 members shall be elected in the General body meeting once in three years.
- d. The Secretary may call for a General body meeting for which 21 days notice shall be given to the members.
- e. The Executive committee shall meeting once a month for which the Secretary shall give notice of 7 days to the members.
- f. Voting shall be conducted by show of hands or Secret Ballot.
- g. 21 days clear notice for the annual general body meeting and 21 days notice for the Special General body meeting shall be given, and the subject matters to be discussed shall be stated in the notice.
- h. Special General body meeting shall convene as per Sec.11 (3) of the K. S. R. Act, 1960.

4. Quorum

The quorum of the General body meeting shall be 2/3rd of the total membership of the Association.

5. Accounts

- a. The official year of the Association shall be from 1st April to 31st March.
- b. The assets and liabilities, the balance sheet of the Association shall be prepared and laid before the Annual General body meeting for confirmation.
- c. Such a balance sheet and the list of Committee members shall be filed with the Registrar of Societies as per Sec.13 of the K. S. R. Act, 1960.

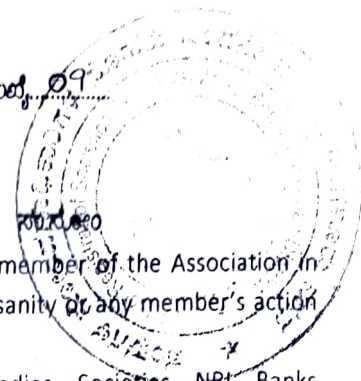
6. Auditor

An Auditor shall be appointed annually and the remuneration shall fixed by the members in the Annual General Body meeting. A Chartered Accountant shall duly audit the accounts.

7. Executive Committee

- a. To ensure and promote the primary aims and objectives of the Association
- b. To publish Annual report/accounts.
- c. To operate funds and manage the property of the Association and to present the duly audited accounts at annual general body meeting.
- d. In the event of any office bearer laying down office for whatever reasons, the Managing committee can co-opt any member consider suitable for the office for the remaining period of the tenure or till election are held.
- e. To ensure utilization of income towards promoting the objectives of the Association

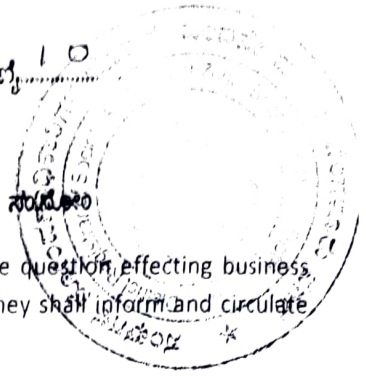

- f. May decide to expel a member of Managing committee or member of the Association in case anyone is convicted of any criminal offence, or prove insanity or any member's action in contravention to the Byelaws.
 - g. To accept from Government, Non-Government, Local Bodies, Societies, NRI, Banks (Nationalized/Co-operative) and individuals Grants, Donations, Loans, Subscriptions or any property movable or immovable for furtherance of the objectives of the Association
 - h. At any meeting of the Executive committee each member present will have one vote except the President who shall have in addition a casting vote. Voting may be by rising of hands or Secret Ballot.
 - i. To ensure that all monetary transaction are through objectives of the Association
 - j. Managing committee shall have power to appeals and raise funds and fulfill and formalities incumbent upon it.
 - k. Executive committee may appoint a committee, Sub-committee with such powers deemed fit by this body for the purpose of incommensurate with objectives. The committee, Sub-committee may co-opt persons who are members of the Association
 - l. Executive committee may invite to their meetings not more than two specialists/experts who may be non-members of the Association whose presence with the deliberations is considered useful.
 - m. To open bank account in the name of the Association in Nationalized/Co-operative/Scheduled bank, Private finance institution and operate by Secretary jointly with the Treasurer of the Association.
 - n. Executive committee shall arrange for the publication in any manner Association journal, documents as may be considered fit in the furtherance of its objectives.
 - o. To make the rules and Byelaws and get approved.
 - p. To acquire or purchase, take on lease, hire or by gift or other wise and hold any moveable or immovable property or properties or any right or privileges that may be deemed necessary or useful for the advancement of the objects of the Association
 - q. The Governing Body shall not admit members during the last three months of its tenure.
 - r. Election: Any member who is desirous of standing for the election as a member to the council of management shall be a member of the Association for at least 12 months prior to the date of nomination.
8. Any vacancy that may arise in the Executive committee may be filled in by the remaining committee members.
 9. Any member of the Executive committee being absent for three successive meetings without proper cause shall cease to be a member of the Executive committee.
 10. The Executive committee is to meet every month or earlier is any business to consider and Secretary shall convene such meetings 2/3rd shall quorum.

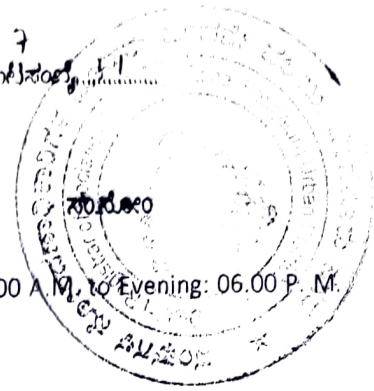

11. The executive committee in its meetings shall consider the entire question affecting business that may be of interest to the members of the Association and they shall inform and circulate any information, which may be of use to the members.
12. **Investment**
The funds of the Association shall be invested in the modes specified under the provisions of Sec.13 (1)(d) r.w.s.11 (5) of the I. T. Act, 1961 as amended from time to time.
13. **Amendment**
Provided that no amendment to the Memorandum of Association, Rules and regulations of the Association shall be made which may prove to be repugnant to the provisions of Sec.2 (15), 11, 12, 13 and 80G of the Income-tax Act, 1961 as amended from time to time. Further no amendment shall be carried out without the prior approval of the commissioner of Income Tax.
14. **Dissolution**
In the event of dissolution or winding up of the Association the assets remaining as on the date of dissolution shall under no circumstances be distributed among the members of the Managing committee/Governing body but the same shall transferred to another charitable Association /Association whose objects are similar to those of this Association and which enjoys recognition u/s.80G of the I. T. Act, 1961 as amended from time to time.
15. **Clause 6:**
The benefits of the Association shall be open to all irrespective of the caste creed or religion.
16. **Clause 7:**
The funds and the income of the Association shall be solely utilized for the achievement of the objectives and no portion of it shall be utilized for payments to the members by way of profit, interest and dividends.
17. Alteration or amendment of the Memorandum of Association shall be made as per Sec. 9 of the K. S. R. Act, 1960.
18. Change of Name, Rules and regulations shall be made as per Sec.10 K. S. R. Act, 1960.
19. If the Dissolution of the Association arise Sec. 22 and 23 of the K. S. R. Act, 1960 shall be followed.
20. Regarding the Amalgamation of the Association arises Sec.21 of the K. S. R. Act, 1960 shall be followed.
21. For the matters, which have not been specified, provided to therein above, the provisions of the K. S. R. Act, 1960 and the Rules made there under shall apply.

22. The working hours of the Association will be from Morning: 10.00 A.M. to Evening: 06.00 P. M. on all working days.

23. Executive powers of the Committee

The administration and Management of the Association shall vest in the Executive committee consisting of 09 members including President, Vice President, Secretary, Joint Secretaries, Treasurer and E.C. Members of the Association.

President

He/she shall be over all in charge of the Association and the General body meetings. All the policies and programmes shall be formulated and implemented only through him/her in consultation with executive committee.

Vice President

He/she shall assist President in general; in the absence of the President he/she shall assume the charge of President.

Secretary

He/she shall call for all meetings of the General body meeting as and when deemed necessary and the General body meetings and the Special General body meetings as per the rules with the previous approval of the President and maintain the minutes book and record of all the proceedings of the meetings.

He/she shall be the correspondent of the Association and shall be in charge of the office with all the record of the Association.

He/she shall be the custodian of all articles and belongings both movable and immovable property of Association.

He/she shall file with Registrar of Societies, Bangalore relevant records of the Association for every year stipulated time without fail.

Joint Secretary

He/she shall assist Secretary in general; in the absence of the Secretary he/she shall assume the charge of Secretary

Treasurer

He/she shall be the custodian of all the funds and investments of the Society and all the accounts. He/she shall maintain all accounts and records and shall receive cash on behalf of the Society. He/she shall prepare a Balance sheet of the Income and Expenditure each year for the presentation to the General body with the approval of President and Secretary
