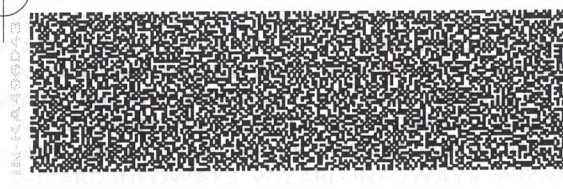
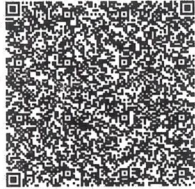

- For any work which is not mentioned in **ITEMS INCLUDED** or mentioned in **ITEMS NOT INCLUDED**, to be considered as additional work. This additional work will be charged based on Hourly effort and will be billable in advance of 50 hrs. Along with signed AMC Contract. Hourly charges would be **750 INR** per hour
- Any work repeated within a week will be considered as Rework and will be charged additionally.
- As soon as this limit exhausted, it will be billed again. It will never expired if there is no additional work done during current AMC period and will be forwarded for next term.
