- The Students who are applying for Post-Matric scholarship for the first time through SSP should get their student account created in SSP by providing their Aadhaar, Caste & Income/EWS certificate\* details before starting with application submission and for higher semester students by using their Previous SSP ID.
- Your Aadhaar Name & SSP application should be according to your X marks card.
- Student Aadhaar number should be seeded with their Bank account to (NPCI) National Payment Corporation of India.
- Upload the documents only if requested online for E-attestation.

### 3. Types of Scholarships

### i. REVA EET Scholarship:

REVA University conducts entrance examination known as REVAEET every year before the admission for all the programs being offered. The top ranked students in all the programs are awarded scholarships as detailed below.

REVA University has instituted scholarship for the children of personnel who served in various Defence and police forces to recognize their service rendered in Defence, Central Armed Police Forces and other sister Organization, such as Indian Army, Indian Navy, Indian Air Force, Coast Guard, Central Reserve Police Force (CRPF), Border Security force (BSF), Indo-Tibetan Border Police (ITBP), Sashastra Seema Bal (SSB), Central Industrial Security Force (CISF), Railway Protection Force (RPF), National Security Guards (NSG), Special Frontier Force (SFF), Assam Riffles, Border Road Organization, General Reserve Engineer Force (GREF), Defence Research and Development Organization (DRDO), Military Engineers Service (MES) and Defence Security Corps (DSC).

In addition to the above scholarships REVA University provides fee concessions to the students who register for admission and enroll their name by paying initial prescribed fee under the title "Early Bird Scheme". The amount of such fee concessions shall be decided by the Scholarship Selection Committee from time to time.

### 4. Eligibility Criteria

The guidelines for eligibility for Scholarship shall be as decided by the Scholarship Selection Committee and approved by the Chancellor.

The eligibility criteria so decided by the committee and approved by the Chancellor shall be clearly indicated in the notification inviting applications for scholarships and the same shall also be printed on the application form.

While awarding the scholarship, several other indicators are also considered that may include previous academic scholarship award, excellence in extracurricular activities, and financial hardship of meritorious candidates as identified in the application form.

All eligible students are required to submit the university scholarship application form well within the stipulated time.

## 5. Procedure for Award of Scholarship

- a. The University shall issue notification soon after admissions are completed inviting applications from the students belonging to the above categories of students. The notification shall clearly mention the terms and conditions of awarding the scholarship and the last date of receipt of application.
- b. Applications filled in prescribed form (appended in Annexure -I) must be submitted by the candidates through the respective School Directors.
- c. Within seven days of last date of receipt of applications the Office of the Registrar must scrutinize all applications received from students, convene the meeting of the Scholarship Selection Committee, and place the scrutinized applications before the said Committee for selecting the deserving candidates for award of scholarship.
- d. After the meeting of the Selection Committee the list of students recommended for award of Scholarship along with proceedings of the committee may be placed before the Vice Chancellor and the Chancellor for approval.
- e. After obtaining the approval of the Chancellor it shall be notified and the concerned students be informed through the Director of respective schools.
- f. Incase the number of applications received for award of Scholarship are less than the number of Scholarship being awarded, the Office of the University, itself shall scrutinize and verify the eligibility of the candidates for Scholarships and submit it to the registrar after recording the status of the applications received scrutinized and verified. Hence there is no need to convene the meeting of the Scholarship Selection Committee.

### 6. Scholarship Selection Committee

There shall be a Selection Committee consisting of the following:

a. The Registrar - Chairman

b. One Dean nominated by the Chancellor. - Member

c. Finance Officer or his Nominee, not below the rank - Member

of Office Superintendent

d. Deputy Registrar/ Administrative Officer - Academic - Member Secretary

## 7. Selection of students for award of Scholarship:

- a. Select the candidates based on the merit of the marks obtained in qualifying examination.
- b. If more number of students than total target stipulated for the academic year submit the application, the Scholarship Selection Committee shall decide about including the higher number in consultation with the Vice Chancellor and recommend the same to the University recording the facts.
- c. If two candidates have the same marks, then the preference to be given for the women candidate.
- d. When both the candidates of the same sex then the selection to be made based on the seniority by date of birth incase of dropping the candidate from the Scholarship award list.
- e. After the completion of the verification of the documents, the list of qualified candidates has to be submitted to the Registrar to obtain approval from the Vice Chancellor and the Chancellor.
- f. The selection committee may request additional information and documents as deemed appropriate. This may include scholarly activities of the applicant like participation in various activities which are pointers towards academic excellence.

#### 8. Award Notification

- a. After obtaining the approval from the Chancellor for the list of the students for award of Scholarship, the Registrar shall notify the same and send communication to the concerned students through the Director of the respective Schools.
- b. The notification shall clearly mention the amount, type of scholarship partial/full/tuition fee waiver for specific period/special categories, duration and terms of reference for renewal and termination of scholarship.
- c. Students have to sign the scholarship acceptant effecter before the last date.

- d. As a matter of policy the University awards only one scholarship in a year to a particular student. The awardee is communicated the same and is advised to go through the terms and conditions to avail the scholarship and sign the acceptance letter.
- e. The facility may be withdrawn by the University at any time if the candidate is found ineligible for the same.

# 9. Renewal of Scholarship

- a. Semester wise scholarships are given subject to fulfillment of eligibility criteria.
- b. The scholarship for remaining semesters is renewed if the student clears the subsequent exams with no backlog and satisfies all the other conditions as set out in the policy.
- c. The Selection Committee makes careful semester-wise/ year-wise assessment of students in terms of academic as well as adherence to University code of conduct. While considering renewal of the scholarship.
- d. The decision of renewal or rejection is on a case to case basis as considered suitable by the committee.
- e. If a student is considered ineligible on specific grounds the award may be given to other deserving candidate as per guidelines of the University.

### 10. Scholarship Progression and Character

- a. The awardee must maintain strict adherence to the rules and regulations of the University and should possess a clear record in terms of discipline and character.
- b. Any act of vandalismor misbehavior entertains disciplinary action and withdrawal of the scholarship facility.
- c. In such circumstances the university shall issue notification withdrawing this scholarship facility.
- d. It goes without saying that the University considers its student as a brand ambassador and expects exceptional behavior.

### 11. General Terms and Conditions

- a. Number of scholarships to be considered in an academic year is subject to change considering the availability of funds, merit of enrolled students.
- b. Only one scholarship for the student in a particular academic year subject to renewal, if all conditions are fulfilled.
- c. The validity is at the sole discretion of the committee.
- d. Tuition fee waivers, if any, shall be considered on a case-by-case basis for each

program.

- e. The competent authority decides the mode of redeeming the scholarship amount. All records of the awardee with respect to academics and behavior are thoroughly examined prior to renewal of the award of scholarship.
- f. All the eligible students must apply for the scholarship in the prescribed university application forms after completion of the enrolment and/or at the time of enrolment.
- g. Scholarship applications received after the due date shall not be considered for the scholarship award selection process.
- h. The scholarship amount allotted for each program is based on a financial resource available. The financial status database for each academic year shall be maintained by the selection committee. Likewise, tuition fee waiver and other financial support shall be considered as per the recommendation of the scholarship selection committee.
- i. Any scholarship awardee who discontinued the studies must repay the fee of completed semesters in complete and or return the scholarship amount paid as per the scholarship guidelines of the university.
- j. Scholarship awardee must maintain satisfactory performance in all the semester with no backlog and maintain a model code of conduct.
- k. University shall have the right to utilize the scholarship awardee for promotional activities and the awardee shall be ambassador of the university.
- 1. Scholarship application form is subject to change, as deemed appropriate, to include the refined criterion to enable effective selection process.
- m. No student is allowed to hold more than one scholarship at a time, irrespective of type and amount of scholarship and or study support donations.
- n. The student needs to pay the provisional admission fee on or before the last date so notified.
- o. Semester wise scholarships are given subject to fulfillment of eligibility criteria.

p. It is the responsibility of the student to submit all documents along with application for consideration. Incomplete or inadequate information will render the application rejected.

# **CENTRAL SECTOR SCHEMES & ELIGIBILITY:**

### 1. POST MATRIC SCHOLARSHIP SCHEME FOR MINORITIES:

- a. The Student should belong to Karnataka State Domicile & Minority (Muslim/Christian/Sikhs/Buddhists/Paris & Jain) Communities.
- b. Student should have scored 50% in previous academic year.
- c. Parents Annual Income should not exceed more than Rs.2 Lakhs/Annum.
- d. A Self certified Community Certificate.

# 2. MERIT CUM MEANS SCHOLARSHIP FOR PROFESSIONAL AND TECHNICAL COURSES CS (FOR MINORITIES):

- a. The Student should belong to Karnataka State Domicile & Minority (Muslim/Christian/Sikhs/Buddhists/Paris & Jain) Communities.
- b. Student should have scored 50% in previous academic year.
- c. Parents Annual Income should not exceed more than Rs.2.5 Lakhs/Annum.
- d. A Self certified Community Certificate.

# 3. MHRD/CENTRAL SECTOR SCHEME OF SCHOLARSHIPS FOR COLLEGE AND UNIVERSITY STUDENTS:

- a. Students should have scored more than 80% in PUC/XII or equivalent for the academic year 2021-22 examinations.
- b. Annual Income should not exceed more than **Rs.4.5 Lakhs per annum**.
- c. Age Limit should be 18-25 years.

# 4. NATIONAL FELLOWSHIP & SCHOLARSHIP FOR HIGHER EDUCATION OF SCHEDULED TRIBE STUDENTS:

- a. ST scholars who are pursuing full time are eligible.
- **b.** Should provide valid Caste & Income certificate.
- c. Students family income should not exceed Rs.6 Lakh per annum



# 5. <u>FINANCIAL SUPPORT TO THE STUDENTS OF NER FOR HIGHER PROFESSIONAL</u> COURSES (NEC MERIT SCHOLARSHIP):

- a. Student should be a permanent resident of any North Eastern States.
- b. Students admitted in first year of any UG & PG Degree/Technical/Professional courses are eligible.
- c. Parents annual Income should be below 8 Lakhs/per annum.

# 6. <u>FINANCIAL ASSISTANCE FOR EDUCATION OF THE WARDS BEEDI/CINE/OMC/LSOM WORKERS</u> (LABOUR & EMPLOYMENT)

- a. Either of the parents of the students should be Beedi, Iron, Ore Manganese & Chrome Ore Mines, Limestone & Dolomite Mines, Cine worker with at least six months service.
- b. Beedi workers & Mine workers wages or salary should be below Rs.10,000/- monthly and Cine workers wages or salary Rs.8000/- monthly.
- c. Students should have passed their previous examination in first attempt and admitted in first year of any Degree/Technical/Professional courses are eligible

# 7. PRIME MINISTER'S SCHOLARSHIP SCHEME FOR THE WARDS OF RPF/RPSF (RAILWAY POLICE FORCE/SPECIAL FORCE)

- a. Wards/widows of ex-RPF/RPSF personnel who died in harness due to causes attributed to encounter with terrorist or with criminals while protecting Railway Property, Passenger, Passenger Area or those who died during election work.
- b. Wards/widows of ex-RPF/RPSF personnel who died in service.
- c. Wards of ex-RPF/RPSF Serving & Retired Personnel.
- d. Should have scored 60% in their previous academics
- e. Pursuing in 1<sup>st</sup> year all UG Programs and MBA, MCA.

# 8. PRIME MINISTER'S SCHOLARSHIP SCHEME FOR WARDS OF STATES/UTs POLICE CAPF/AR (CENTRAL ARMED POLICE FORCE, ASSAM RIFLES) PERSONNEL MARTYRED DURING TERROR/NAXAL ATTACKS.

- Wards/widows of CAPF/AR personnel killed in action/deceased/disabled while in service/during conduct of election
- b. Students should have scored more than 60% in PUC/XII/Diploma/Degree or equivalent examinations for the academic year 2021-22.
- c. Wards/widows of retired and serving CAPFs & AR Personnel (Below Officer Rank).


